# TERMS & CONDITIONS

## BINDING THE CELEBRITY DRESS & THE CUSTOMER

Please read The Celebrity Dress' Made To Measure special order form policy carefully to ensure you are fully aware of your rights and our obligations to you.

1. The Celebrity Dress will manufacture the garment in accordance with the details as set out on page 1 of this Order Form.
2. The customer order will be fulfilled and the garment delivered (subject to any delays occasioned by Australia Post in the postage/ shipping of the garment to the customer) within 30 days from the time of the order placement, provided that full details have been supplied to The Celebrity Dress by the customer as is required on page 1 of the Made To Measure Order Form and the full purchase price has been paid. Shipping and postage times cannot be guaranteed by The Celebrity Dress, however all steps will be taken to ensure the tracking of the parcel, should this service be required,
3. The customer agrees to pay for the item in full, including GST at the time of order placement.
4. The Celebrity Dress will manufacture the garment ordered in the fabric colour and/or pattern selected by the customer. In the event that The Celebrity Dress cannot meet the order in the fabric colour and/or pattern selected by the customer due to the unavailability of fabric selected, it will immediately advise the customer as soon as is practicable after the date of the making of the order and allow the customer to select whether a) it wishes to amend the order to a different colour and/or pattern as advised by The Celebrity Dress or b) cancel the order of the customer and obtain a full refund of the payment made by the customer.
5. Made to Measure garments will be sewn according to the size specifications requested by the customer. Should any alterations be required by the customer either at the time of receiving the garment or anytime after this date, this will be the responsibility of the customer and at the customer's expense.
6. Should The Celebrity Dress experience any unforeseen delays beyond its control in meeting the order within the 30 day of its making, The Celebrity Dress will be entitled to advise the customer the reason for the delay and to either extend the 30 day time limit by the number of days that resulted in the unforeseen delay, or cancel the order and refund the customer's money. Should such extension exceed a further 14 days, the customer will be entitled to a refund of all funds paid at the time of order placement.
